



**LTI COVID-19/Coronavirus Visitor/Contractor Disclosure and Approval Form**

The health and well-being of our employees, visitors, families and communities remain Laboratory Testing Inc’s (LTI’s) primary priority as part of the careful strategy to comply with both Public Health Agency requirements and customers’ operational continuity expectations for life-essential industries in response to the COVID-19 (coronavirus) pandemic. As such, LTI requires all business-essential visitors respond to all the questions below and sign prior to being considered for entry into our facilities. Also, it is strongly recommended that all business-essential visitors **bring and wear a suitable protective mask** to cover their mouth and nose, wear gloves and remain at least 6’ apart when interacting with LTI employees inside LTI facilities.
